- 6) That, any change in my financial status will be brought to the notice of MAHAJYOTI immediately.
- 7) That, the financial assistance under the said fellowship is awarded to me for the research subject mentioned in my registration letter submitted to MAHAJYOTI.
- 8) That, I will be eligible for following financial assistance, applicable to me, from w.e.f. _____ under MJPRF-20__, whichever is later and limited for my remaining period of Ph.D. (out of total period of 5 years) or the date of submission of Ph.D. thesis, whichever is earlier.

Further that, the financial assistance under the fellowship will be limited for my remaining period of Ph.D. (out of total tenure of 5 years) and the same will be calculated from date of joining the University/Institute/College up to the date of completion of my remaining tenure of Ph.D. (out of total 5 years) or up to the date of submission of thesis, whichever is earlier.

- **viii.** After completion of two years of award of fellowship MJPRF, an 'Upgradation Certificate' and evaluation report of three-member Committee will have to be submitted in the prescribed proforma. (**Annexure VIII**)
- 12) That, I will provide all the above information in the prescribed formats given by MAHAJYOTI, from time to time.
- 13) That, the progress report will be evaluated by a committee of MAHAJYOTI and will be submitted to Managing Director, MAHAJYOTI. Depending on the six-monthly progress report, release of fellowship amount of last six months will be considered by MAHAJYOTI. In case of non- satisfactory progress of the candidate, MAHAJYOTI will take due cognizance including reducing the amount of the fellowship or non-release of fellowship amount.
- 14) That, I am not allowed to accept or hold any position in the list of employees, in any institute with paid or unpaid appointment. I am also not allowed to accept full time, part time or on Clock Hour Basis (CHB), or receive emoluments, salary, stipend, fellowship, honorarium etc. from any other source during the tenure of the MJPRF- 20__. In case it is found that, I have breached this condition, MAHAJYOTI will discontinue its financial assistance to me, without any notice and financial assistance under MJPRF- 20__ already provided to me, will be liable to be recovered from me and in such a case, I will refund the entire amount of financial assistance given to me by MAHAJYOTI.

- 15) That, I fully understand and accept that, if there is any lapse on my part, I shall not be eligible for the Financial Assistance under MJPRF 20___, from MAHAJYOTI.
